Answer to questions

1. Do you have an estimated budget? **Answer:** No
2. Where is Ion Crossroads? **Answer:** Ions Crossroad is the intersection of Jacksonboro Road and Round O Road, south of Cottageville. It is about half way between Jacksonboro and Cottageville on Jacksonboro Road.
3. Please advise if a bid bond is required. **Answer:** Yes, a Bid Bond is required.

THE BIDDER SHALL ACCOMPANY EACH BID WITH BID SECURITY IN THE FORM OF A 5% BID BOND OR A CERTIFIED CHECK.

THE BIDDER REPRESENTS THAT HE WILL ENTER INTO A CONTRACT WITH THE OWNER FOR THE DOLLAR AMOUNTS OF THE BASE BID AND ALTERNATES, IF ANY, AND THE UNIT PRICES, IF ANY, STATED IN HIS BID AND THE WRITTEN REQUIREMENTS CONTAINED IN THE PROJECT MANUAL.

SHOULD THE BIDDER REFUSE TO ENTER INTO SUCH CONTRACT AND OR FAIL TO FURNISH SUCH BONDS, IF REQUIRED, THE AMOUNT OF THE BID SECURITY SHALL BE FORFEITED TO THE OWNER AS LIQUIDATED DAMAGES, NOT AS A PENALTY.

FOR THE PURPOSE OF EXECUTING THE BID SURETY FORMS OR CERTIFIED CHECK, THE OWNER IS COLLETON COUNTY, WALTERBORO, SOUTH CAROLINA.

TO BE ELIGIBLE TO WRITE THE BID SURETY BOND, THE SURETY COMPANY MUST BE LICENSED TO DO BUSINESS IN THE STATE OF SOUTH CAROLINA AND SHALL ALSO BE ACCEPTABLE TO THE OWNER.
