REGULAR MEETING MINUTES Tuesday, August 12, 2025, at 6:00 P.M.

Chairman Scott Biering called the meeting to order with Council Members Bubba Trippe, Steve Murdaugh, Phillip Taylor, and Johnny Frank were in attendance.

Councilman Taylor gave the invocation and led the Pledge of Allegiance.

Approval of Agenda

Councilman Murdaugh made a motion to approve the agenda. The motion was seconded by Councilman Trippe and the motion carried unanimously.

Councilman Murdaugh moved to approve the minutes of the Regular Meeting held on July 8, 2025. The motion was seconded by Councilman Taylor and the motion carried unanimously.

Councilman Murdaugh moved to approve the minutes of the Special Meeting held on July 16, 2025. The motion was seconded by Councilman Taylor and the motion carried unanimously.

Awards and Recognitions

Chairman Biering read the Proclamation; Recognizing the Outstanding Service of Colleton County Fire-Rescue, Colleton County Sheriff's Office, South Carolina Highway Patrol, Other First Responders and Hospital Staff in Response to the Tragic Accident on Interstate 95 into the record. Councilman Murdaugh made a motion to approve the proclamation. The motion was seconded by Councilman Frank and the motion carried unanimously.

Council commended the professionalism, bravery, and collaborative efforts of all agencies involved, expressing gratitude for their tireless work and dedication to the citizens of Colleton County.

Appearances & Public Presentation



Community Innovations; Shiela Keaise; Colleton Voice-Winners

Ms. Sheila Keaise, founder of Community Innovations, introduced the organization, explaining its focus on children, teens, and adults through four pillars: health, mentoring, education, and parenting. She highlighted key programs, including "Raising Highly Capable Kids," the "Colleton Voice," the "Literary Tea with Palmetto State Authors," the "Family Fun Zone" (formerly family carnival), the "Young Authors Program," and the "CI Leadership Awards." Community Innovations also conducts "Christmas with Seniors," where they spend time with elderly individuals, and a mentoring program for young people.

Sheila Keaise introduced the 2025 Colleton Voice Winner, Miss. Jasmine Cheryl. Ms. Sheila Keaise gave a little background on Miss. Jasmine Cheryl, advising that she is 12 years old, and hails from Kenya.

Miss Jasmine Cheryl introduced herself to Council and graced the audience along with Council by singing "The Truth by Megan Woods".

Council commended Miss. Jasmine Cheryl on a job well done.

Public Comments (3 minutes per person/max time 20 min.)

Frank Santorella addressed the Council and spoke about the positive impact that the power plant will have on Colleton County.

Sue Keith addressed the Council to inform them of the upcoming Legislative Delegation meeting on September 29, 2025 at the Colleton County Memorial Library.

Herbert Hires Jr. and Mrs. Devin Martin addressed the council regarding recent dog attacks on their cows, which caused significant damage to their livestock. They expressed frustration with animal control's response, stating that the officers felt their hands were tied and that little action was taken to prevent further attacks. Philip Adams and Michael Adams echoed these concerns, emphasizing the financial and emotional toll of the attacks and questioning the lack of effective enforcement of existing animal control ordinances.

Colette Bailey, a goat farmer and dog breeder, presented South Carolina ordinances related to aggressive dogs, highlighting that current laws allow for prosecution of owners with fines and jail time. Colette Bailey questioned why these laws were not being enforced, citing the recent pit bull attacks and the broader issue of dog fighting in the state. Colette also questioned whether the Sheriff's office should be handling certain types of call as opposed to Animal Services.

Councilman Murdaugh made a motion to raise a Point of Privilege, to address the immediate needs in the room. The motion was approved by Council.

Councilman Murdaugh wanted to first address the concerns over animal control. He advised that the Ordinance received by Ms. Colette Bailey is in fact a Colleton County Ordinance. Councilman Murdaugh advised the public that their message is being heard and that Councilman Trippe is having



a meeting with animal control to address the various issues. Councilman Murdaugh also reassured the public that he had full confidence that Councilman Trippe and his committee would come back to Council with good recommendations to come to a resolution.

Several members of Council provided their personal opinions on the proposed power plant project at Canadys, acknowledging the concerns of residents living near the river but also noting the positive impacts. Councilman Murdaugh emphasized the importance of the project for the county's infrastructure and growth, highlighting that while there are risks, technology like carbon mapping can help mitigate potential issues related to methane gas leaks. Councilman Murdaugh also advised that Dominion Energy and Santee Cooper shouldn't be criticized for the route they have chosen, they should be applauded, because they chose a route that specifically went around the Ace Basin. Councilman Murdaugh advised the public to always be leery of the message that is being received. Councilman Taylor concurred with Councilman Murdaugh. He also advised that Council had already expressed their consent to the project several weeks ago, and explained if something was needed in writing, then we should direct the Administrator to move forward. Councilman Trippe concurred with all of Council as well as being 100% in support of the plant coming to Colleton County. Councilman Frank advised that when the County gets power, it doesn't just come from the Canadys power plant, it comes in from Georgia and all over the place. Councilman Frank reiterated that a lot of people utilize this power and reminded the public of the tax loss the County took when the SCEG plant shut down. Councilman Biering also expressed that he would take a point of privilege as well, by concurring with everything that has been stated by Council tonight. Councilman Biering wanted to make aware that no major energy production has made an investment in this state Councilman Biering also advised that the pipeline would run through Santee in seven years. Coopers' existing right-a-ways, and that the tax revenue that can come from this is not only lifechanging, but also generational changing for Colleton County.

Administrator's Briefing

County Administrator Thomas Higgs gave his briefing, advising Council that both regional partners at Dominion and Santee Cooper have reached out asking for a letter of support as they work through FERC (Federal Energy Regulatory Commission). He advised that if there was no objection from Council the County would proceed with sending the letters out

The County Administrator then addressed the recent livestock incidents, expressing condolences and detailed staff efforts to address deficiencies in Animal Services. Mr. Higgs announced an expedited Public Health and Safety Committee meeting scheduled for the following evening, August 13, 2025, at 5:30 PM to review Title Six, which covers animal control. Mr. Higgs stressed the importance of equipping staff with the necessary tools to prevent future occurrences so that Animal Services can complete the job required for the citizens of Colleton County.

Public Hearing

Councilman Taylor made a motion to open Public Hearing. Councilman Murdaugh second the motion, and the motion carried unanimously.

Councilman Biering opened the floor for the public to speak on; Ordinance 25-O-07, Authorizing the Execution and Delivery of a Fee In Lieu of Tax and Special Source Credit Agreement by and

Councilman Taylor amended his motion to include that next Council meeting to be held on the second Monday in September. The motion carries unanimously.

Councilman Frank wanted clarification from the County Administrator if the Grant provided a match by the County. County Administrator advised that no match was required.

County Administrator addressed Council advising that the County is currently working with Santee Cooper, Dominion and the pipeline company and will be working closely with the delegation to make sure the public is fully informed. Councilman Trippe invited all to the Emergency Public Health and Safety Committee Meeting that is being held on August 13th at 5:30pm. Councilman Murdaugh wanted to clarify that not all members of Council would be present at that meeting due to the structure of the meeting and how they are designed to only have three members of Council on each. Councilman Murdaugh advised that he was not on that committee, but that Councilman Trippe would bring all information back to the full Council for discussion.

Executive Session

Councilman Frank made a motion to move into Executive Session to discuss the following: Matters Concerning Economic Development is relation to Project Fanatic, Project Craft, Project Badger, Project Quail, and FILOT Fees; along with Personnel and Contractual Matter related to the Office of County Administrator. Councilman Murdaugh seconded the motion, and the motion carried unanimously.

Councilman Frank made a motion to exit Executive Session. Councilman Murdaugh seconded the motion, and the motion carried unanimously.

Councilman Biering advised that no other action was taken during Executive Session

COLLETON COUNTY COUNCIL Public Health and Safety Committee Meeting Tuesday, August 13, 2025, at 5:30 P.M.

MEETING MINUTES

1. Call to Order

Chairman Bubba Trippe called the meeting to order and thanked everyone for being in attendance.

2. Invocation & Pledge of Allegiance

Councilman Taylor gave the invocation and led the Pledge of Allegiance.

3. Roll Call Committee Members

Council Members Scott Biering and Phillip Taylor were in attendance with Chairman Bubba Trippe.

4. Approval of Agenda

Councilman Taylor made a motion to approve the agenda. The motion was seconded by Councilman Biering, and the motion carried unanimously.

5. Citizen Comment Period*

Mark Filion addressed the ongoing animal problem in Colleton County, emphasizing that Animal Services' hands are tied due to current regulations. He stated that the core issue is not with the animals or Animal Service, but with irresponsible owners, citing a case involving Adams's cows where ownership was disputed. Filion advocated for solutions like registering and microchipping animals to definitively link them to owners, thereby enforcing accountability.

Kay Herndon presented the severe financial impact on the Adams family, whose cattle were mauled, noting their significant monetary investment in the animals. She highlighted that the damaged cattle, some of which had lost ears and suffered utter injuries, would be difficult to sell at their original value, resulting in estimated losses of \$8,000 to \$10,000. Murdaugh questioned why existing laws, if present, were not being utilized to prevent such incidents and support affected owners.

6. Discussion of Colleton County Ordinance Title 6, Chapter 6.04 "Animal Care and Control Regulations"

The Committee expressed empathy for those affected by the animal attacks, acknowledging the distress caused by property and animal loss. They emphasized the importance of consulting experts and staff trained in relevant fields for policy development, rather than relying on

informal opinions. Council conveyed their hope that the county administrator would share insights to help the committee find a respectful and effective path forward for all involved.

County Administrator Thomas Higgs advised that his team met with Animals Services today to go over the changes that would need to be implemented and what that would look like going foward. Mr. Higgs emphasized the importance of accountability and transparency within Animal Service operations, stating that new Standard Operating Procedure (SOP) amendments will make these a reality. Mr. Higgs also highlighted the implementation of a report system for every call, similar to police reports, to enhance accountability and follow-up, and mentioned the continued use of body cameras as a significant tool. He also recommended improving pet ownership accountability through measures like microchipping or documentation to help track dog owners, as current difficulties in identifying owners hinder proper law enforcement. Mr. Higgs addressed concerns about the safety of animal control officers, noting that they do not fall under the Sheriff's office and lack law enforcement powers, such as NCIC data, which compromises their safety when responding to unknown situations.

Councilman Taylor suggested taking some of these issues to the South Carolina Association of Counties to seek state-level policy positions, including potential certification or NCIC access, to empower animal control officers.

7. Adjournment

Councilman Taylor moved to adjourn the meeting. Councilman Biering seconded the motion, the motion carried unanimously.

PROCLAMATION RECOGNIZING AND HONORING THE MEMBERS OF THE SOUTH CAROLINA STATE GUARD AND NATIONAL PREPAREDNESS MONTH SEPTEMBER 2025

WHEREAS, September is observed as National Preparedness Month to raise awareness about the importance of preparing for emergencies and to build resilience before disasters strike; and

WHEREAS, counties and municipalities throughout South Carolina have been affected by a variety of disasters and emergencies, including ice storms, flooding, earthquakes, hurricanes, and the COVID-19 pandemic; and

WHEREAS, the residents of Colleton County deeply appreciate the protection that the South Carolina State Guard has provided to the citizens of this great State for more than three hundred fifty years; and

WHEREAS, authorized by the South Carolina Code of Laws, the State Guard is a professional military organization and component of the South Carolina Military Department which supports a variety of critical functions of the state, county, and municipal governments, such as providing disaster-relief assistance to communities and local first-responder organizations; and

WHEREAS, the South Carolina State Guard traces its earliest manifestation to the formation of the Charleston Militia in 1670, the colony's first military organization, protecting residents in earliest days from pirates, foreign invaders, and Native- American raids; and

WHEREAS, throughout the Revolutionary War the State Guard played a pivotal role in recapturing the South from British control with leaders, such as Francis Marion, "The Swamp Fox"; Thomas Sumter, "The Gamecock"; and Andrew Pickens, "The Wizard Owl"; and additionally played key roles in later conflicts such as early 19th century battles against the Spanish in Florida, the Mexican War, and the Spanish-American War; and,

WHEREAS, the State Guard is organized as an army brigade under the leadership of the Commander and is comprised of the Command Staff, the Chief of Staff Section, the Professional Services Command, and the 1st Civilian Support Brigade, which is further divided into three battalions. The battalions are divided into companies which correspond to the boundaries of the six regions of the South Carolina Emergency Management Division; and

WHEREAS, the State Guard trains new members at the McCrady Training Center in Eastover to provide a number of services: search and rescue operations, medical support, legal and engineering expertise, chaplain and counseling services, directing distribution of supplies, providing military funeral honors to veterans, executive governmental affairs that serves as a liaison to the Governor's Office and the Legislature as well as building relationships with military and civic organizations across the State; and

WHEREAS, when serious natural or man-made disasters strike the South Carolina, the State Guard provides "boots on the ground" with the mission to swiftly respond, safeguarding people and property, and to aid community recovery, in coordination with the National Guard, law enforcement, and other state, county, and municipal agencies; and

WHEREAS, the State Guard is part of the South Carolina Military Department and directed by the Adjutant General, and its Commander in Chief is the Governor of the State of South Carolina.

NOW, THEREFORE, Colleton County Council does hereby proclaim SEPTEMBER 2025 as NATIONAL PREPAREDNESS MONTH in Colleton County. Colleton County Council recognizes and honors the members of the South Carolina State Guard and commends their all-volunteer force who nobly provides aid during times of disaster, who shares a passion and strong commitment to their fellow South Carolinians, and who embody the Spirit of National Preparedness Month.
